Marilyn Regier Retires as Barker Executive Director

An Appreciation by Chris Intagliata

Good-byes are tough. Sometimes, though, boundless appreciation and gratitude for a leader's service overwhelms the sadness. That's my state-of-mind today in recognizing Marilyn Regier's retirement as Executive Director of the Barker Adoption Foundation. When Marilyn first joined the staff, she asked me to write the newsletter article announcing her appointment. Since I am now coming full circle with this column, I beg the reader's indulgence to write from a personal perspective.

In the fall of 2002, The Barker Foundation was an agency in crisis. The legacy of passionate commitment within the Barker community remained strong, but two years of leadership turmoil following Robin Allen's retirement had left many of us on the Board wondering how we could regain our footing as an organization united in shared values and thriving in a common mission. I was personally distraught, plagued by the prospect of witnessing the disintegration of an organization I deeply loved. The ray of hope that eventually poked its way through those bleak months was the possibility that the Executive Director post might be filled by Marilyn Regier, a Barker parent and an accomplished director of adoption programs and services at Adoption Service Information Agency. When Marilyn told the search committee that she would accept the position, I wanted to dance and cry at the same time (and as I recall, did a

little of each). I knew that something I cherished had been rescued from the brink.

Fifteen years later, my expectations have been exceeded far beyond what I could have imagined.

In the three years before Marilyn took office, Barker placed an average of 30 children per year. Over the past decade, the agency has averaged 102 placements annually. Moreover, this growth has occurred in a difficult adoption environment – with significant cuts in international adoption and intense domestic competition from internet operators. But with every challenge, Marilyn and her staff found ways to respond – from developing understanding and acceptance of the special needs program in China to updating the agency website. The result of all those creative and intelligent responses: the creation of more forever families.

As Marilyn always maintains, however, numbers don't tell the whole story. As Barker trustee Shelley Holt, puts it, "We all love Barker and what it means to our families. And Marilyn has shown us what passion and dedication for ethical adoption practices should look like. She has dedicated her career and life for the creation of families, protecting children first and foremost. I have learned so much from Marilyn and am grateful for knowing her."

In reviewing Marilyn's leadership, there are many stories to tell. Marilyn established Barker adoption programs in both China and Korea

and carried the agency through the staggeringly rigorous process of attaining Hague accreditation. She hired the first director of post-adoption, established the post-adoption database, and initiated homeland tours to Colombia. In the last 15 years, Barker has become a more inclusive organization, with communities of color well represented among our Board, staff, and clients. Under her skilled development leadership, Legacy II was launched, currently totaling 10 million dollars and providing more than \$400,000 every year to support programs.

When asked how she views the changes she spear-headed, Marilyn responds, "While it is difficult to choose one single significant aspect, I do think Project Wait No Longer was perhaps the most important initiative during my tenure, because it responded to such a huge national need." The national need to move children from foster care into permanent homes was and remains pressing, but it is the fulfilled *individual* needs of the 121 older children who have gained a family through Project Wait No Longer that remind one of the impact one person can make in the lives of others.

Beverly Clarke, Director of Project Wait No Longer, elaborates:

The impact of Marilyn's work, dedication, and leadership is difficult to put into words, but is so clearly demonstrated in the standards that are held by

It has been the honor of a lifetime to work with such dedicated Boards, staff, and community supporters. There are so many highlights that come to mind, but to name a few: the addition of Korean and Chinese programs; *Project Wait No Longer* for older foster youth; the Colombia Homeland Tour; development of a Post-Adoption Department; concerted outreach to communities of color; website development; and of major importance, the Legacy II campaign. I will leave with no regrets, but rather with a heart full of gratitude to all of you for your support and friendship as we worked on behalf of children and families, and with the satisfaction of knowing that almost every goal I set for myself and the agency has largely been accomplished. None of these accomplishments would have been possible without your devotion, expertise, and generosity. Now it is time for new leadership and new initiatives.

Thank you again for the honor of serving Barker, as we together served those in our immediate and global communities.

this agency. Her commitment to ethical adoption and supporting the families we have helped to create has always come first, and is evident in the advocacy work and the programming offered by Barker. Marilyn has a unique ability to engage people, and I have often been in awe of the sheer number of meaningful and supportive relationships she has maintained through the years.

Those relationships can change the agency, often in small ways, and sometimes profoundly. I sat next to Marilyn at the Angels in Adoption event where we first heard Jelani Freeman speak about the needs of children in foster care. I could see the glint in Marilyn's eye as she

determined to contact this compelling young man. Twelve years later, Jelani has become a key member of the Board of Trustees and the Barker community, contributing the skills and perspective that Marilyn recognized we needed. As always with Marilyn, the contributions flow in both directions. "Marilyn has helped foster my growth as a person," Jelani writes. "She has afforded me community, connection and love in abundance. And she has served as a role model for me – a true professional, respected by all, doing her work with heart and passion."

Marilyn's combination of business and marketing savvy, effective management of people,

and emotional intelligence not only brought Barker out of crisis and re-established a coherent, ethical standard for the organization, it lifted the agency into new spheres of stability and influence. John Harris, former Chair of the Barker Board of Trustees and member of the search committee that hired Marilyn, reflects, "When I think of Barker, I think of Marilyn Regier. Her fifteen years of strong leadership, vision, and grace transformed Barker into a world-class organization."

Good-byes are tough. And while I won't guarantee no tears will be shed, I'd say a dance of celebration is in order – to thank Marilyn for the strong and vibrant gift she's leaving us. ■





Barker Staff Presentations

PWNL Director **Beverly Clarke** teamed up with Brandi Hill, Supervisor of the Adoption and Guardianship Unit at Prince George's County Department of Social Services to present at the Adoption Exchange Association conference in Las Vegas, and at the Family Focused Treatment Association conference in Chicago, sharing Barker's highly effective model for private/public partnership in PWNL. These presentations are part of Barker's commitment to being a change agent within the public child welfare system.

Varda Makovsky, Barker's Director of Family and Post-Adoption Services, was selected as a presenter at the National Council for Adoption's annual conference on June 22th in Denver Colorado. Her presentation entitled "The Impact of the Internet and Genetic Testing on the Process of Adoption Reunion" explored the significant changes in adoption reunion, and also presented a newly developed counseling model called "retroactive search counseling" designed to help people who are in crisis and seeking assistance after their reunions – instead of receiving proactive reunion counseling. ■
